PRIVACY STATEMENT

SECTION 1 - WHAT DO YOU DO WITH MY INFORMATION?

When you complete the contact us form, I will collect the personal information you provide such as your name, phone number, address and email address.

When you browse this site, I automatically receive your computer's internet protocol (IP) address to provide me with information that helps me to learn about your browser and operating system.

Email marketing: With your permission, I may send you emails about our services, new services and other updates.

SECTION 2 - CONSENT

How do you get my consent?

When you provide me with personal information for the purposes of contacting you for an initial consult, or subscribing to my blog, I understand that you are consenting that your data will be used for that specific purpose only. This is typically done on a third party, therefore Christine Roebuck and Live My Life Debt Free are not responsible for what happens when you leave my site. That responsibility lies with that third party.

If I ask for your personal information for a secondary reason, like marketing, I will either ask you directly for your expressed consent, or provide you with an opportunity to say no.

HOW DO I RESEND MY CONSENT?

SECTION 3 - DISCLOSURE

I may disclose your personal information with your written consent for sharing videos and photos on social media, or if I am required by law to do so or if you breach our terms of service.

SECTION 4 - THIRD-PARTY SERVICES

In general, the third-party affiliates used by me will only receive your personal data per your written consent. Information collected is confidential and will not be shared otherwise.

However, certain third-party service providers, such as payment gateways and other payment transaction processors, have their own privacy policies in respect to the information I am required to provide to them for your payment related transactions. However, our practice is not to collect or store any credit card information.
